A congenital heart defect is a problem with the heart's structure that is present at birth. This type of heart defect changes the normal flow of blood through the heart. Undergo surgical VSD with Trivial AR with Medical Management. Defect that occurs in about 5 out of every 10,000 babies. It affects boys and girls equally.

Due to their financial condition they have been going door to door for financial support and hence could not operate.

**Mast. Tanvesh Amol Gomase** his health started deteriorating day by day and they took him in to government hospital in Dist. Dharashiv Maharashtra Doctors informed them that he requires an urgent Open Heart Surgery as early as possible.
